Social Audit hian a tum ber chu mipuite chawikanna leh hmasawnna Scheme hrang hrang Sawrkar-in a siam atanga hamthatna dawngtu, a bikin thingtlangmi, hna kalpui a nihna khuaa mipuite leh a scheme buaipitu official zawng zawngte nena tangkawpa, a tha thei ang bera a hlawhtlinna hmuh a nih theihna tura theihtawp chhuaha endik pui hi a ni. Langtlang, rintlak leh awmze nei tako hnathawh reng reng kalpui a nih theihnan leh mipuite hmasawn nan Social Audit hi a pawimawh em em a ni. Amaherawhchu, a dik lo lai chauh hmuhchhuah tuma beihna a ni lo a; A dik zawk inkawhhmuhn a ni tel bawk tih hriat a pawimawh awm e. Mipuite'n an dikna chanvo an hmuh ngei theihna tura hriattir pawh tih makmawh nia hriain Audit neih a nih apiangin hetiang lam hawi hian mipuite hnenah zirtirna pek tel thin a ni bawk.

I. SOCIAL AUDIT

Mipui vantlang kal khawm (Gram Sabha)-in, mipuite hmasawnna atan a hnathawh tur sawrkarin a duan lawk sa leh thawh dan tur a ruahman sate chu, a taka bawhzui a nih dan leh tihpuitlin a nih dante uluk taka khaikhinna, enfiahna leh thil nih dan tur chik taka chhut hona hi Social Audit chu a ni a. Sawrkar kalphungah chutiang taka langtlang leh rintlak taka dan kenkawh leh zawmtirna kawnga Social Audit pawimawhna pawmtu tam tak zingah Comptroller and Auditor General (CAG) pawh a tel a ni. Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA) hi khaw hrang hranga a hnathawhte Social Audit nei tura Gram Sabha hnena thiltihtheihna siamsaka hmalak tirtu hmasa ber a ni. Chuta tang chuan, scheme hrang hrangah pawh hman chhoh a lo ni ta zel a ni.

India ram state tam zawkah Social Audit Unit hi din a ni tawh a. Mahatma Gandhi NREGS bakah Pradhan Mantri Awas Yojana-Gramin (PMAY-G), National Social Assistance Programme (NSAP) Integrated Child Development Services (ICDS), PM Poshan (Mid Day Meal), XV-Finance Commission (FC) Grants, Building and Other Construction Workers (BOCW) leh Public Distribution System (PDS)-ah hnathawh dan enfiah nan Social Audit hi hman mek a ni. Nimahsela, Social Audit nihna leh kalpui a nih danah erawh chuan a mi chengte an danglam angin State hrang hrang tihdan a inang diak diak thei lo a ni.

Sawrkar laipui chuan Comptroller and Auditor General of India (C&AG) berawn chungin States/UT-a Social Audit kalpui dan tur kawng hmang zirtirna leh innghahna atan Mahatma Gandhi National Rural Employment Guarantee Audit of Schemes Rules, 2011 a tichhuak a.

Sawrkar laipui hian C&AG leh Social Audit lama mithiam kalkhawmin thurawn an pek angin Social Audit tichak lehzual tur leh Audit of Scheme Rules, 2011 chu zawm a ni ngei a ni tih ticiang turin Auditing Standards for Social Audit a pho chhuak tel bawk a ni.

Supreme Court-in 19th March, 2018-a thurawn a pek [(in WP (C) No. 318 of 2006 on 19th March 2018], Auditing Standards for Social Audit hi Building and Other Construction Workers (BOCW) Act hnuia insak leh a kaihnawih lam hnathawktute hamthatna kalpui dan enfiahna atan pawha hman theih tura siam ni rawh se a tih chu tihpuitlin a lo ni ta a. Supreme Court-in thupek a lo chhuah angin, Auditing Standards of Social Audit C&AG-in tihchhuah tawh chu BOCW Act hnuia Social

Audit atan pawha hman theih turin, her rem ngai laite her remin hman a ni ta a ni. He thuchhuah hian, BOCWAct hnuia hmalaknate enfiah (Social Audit) chu a lo awlsam zawk nan MGNREG Act, Section 17-na leh Auditing Standards of Social Audit kaikawpa lo din tawh Social Audit Unit chu hman theih a ni tih a tarlang bawk a ni.

Social Audit thil tum ber chu Sawrkar Dan-te, mipui hmasawnna tura project leh scheme ruahmannate chu kalpui a nih danah langtlang leh rintlak taka kalpui a ni em tih tihchian leh hmalak meknate tihchak leh hmasawn lehzual tura tanpui hi a ni. Social Audit chuan heng ruahmanna leh hmalaknaahte hian mipuiah nghawng a neih dan ngaivenin a thlirpui reng a. Chu mai bakah, hnathawh tur ruahmanna leh thil tumte chu mipuite'n an hlawkpui ngei em tih uluk taka chhuizuina leh a tak ngei entirna te hi a ngai pawimawh hle bawk a ni. Sawrkar tha, langtlang leh rintlak siamna kawnga a zung pawimawh, Social Audit chu ng het taka inrem leh kalphung bik nei a nih rualin a tul dan angin siam rem zel theih a ni bawk.

II. SOCIAL AUDIT KAL PUI DAN:

1. **Lehkha pawimawh pek chhuah:** State sawrkar hnuia Building and Other Construction Workers' Welfare Board (MBOCWWB) chuan Social Audit Team-te hnenah Public Hearing neih hma ni 15 a la awm tihin ziaka lehkha pawimawh awm zawng zawng social audit atana tangkai tur reng reng chu Social Audit Unit hnenah a pechhuak tur a ni. Programme Officer chuan heng lehkha pawimawh zawng zawngte hi a awm ngei a ni tih a finfiahin, tluang taka social audit kalpui a nih theihnhan Gram Sabha neih ni tura ruat aia ni 15-a hmain Social Audit Unit hnenah pek a ni ngei a ni tih a tichiang tur a ni.
2. **Finfiahna/Endikna (Lehkha pawimawh&Hna thawhna hmun):** Social Auditor te chuan Audit-na atana Auditing Standard for Social Audit format siamsa zulzuiin hna thawhna hmun ngeiah endikna an nei tur a ni. Tehfung atan hian auditing standards for social audits format siamsaa inziak chauh chu hman tur a ni.

Social Audit-a thil pawimawh palite chu:

- ◎ Mipuite hnena an chanvo leh ruahmanna nihphung pangngai hrilh.
- ◎ Ziaka lehkha pawimawhte chu khua leh tuiten an hriat dan leh mita an hmuh dan nen a inmil em tih finfiah.

- ◎ Hmathatna dawng thei khua leh tui ni simahse chutiang tura ziah luh ni si lote zawn chhuah.
- ◎ Hnathawktute'n awlsam zawka an vuivainate a thlenna tur dik tak hnena an thlen theihna tura kawng kawhhmu.

Social audit chhungin hnathawktu office lam aiawh leh a hna atanga hlawkpuina dawngtu lam pawhin social audit an neihna hmunah an telpui ve thin tur a ni.

3. **Vantlang inkhawm:** Endikna leh khaikhinna kalpui laia thil hmuhchhuah, mipui chanvo dawn chungchangah te leh dik taka sum leh pai te hman a ni ngei em tih chungchangah te hian sawihona nei turin vantlang inkhawm buatsaih ngei hi thil tihmakmawh a ni. Vantlang inkhawm a pawimawh em em nachhan chu, anmahni khawtlang mipuite hriat lai ngeiin, social audit kalpui a nih laia bawhzui ngai leh enzui ngai; khawtlang mipuite'n an duhkhawp lohna leh an vuivaina chungchangah te chinfel nghal ngai leh bawhzui ngaite bawhzui a ni ngei a ni tih mipuiin an hriatna atan a ni.




Chart – II


